The Zamboanga del Sur I Electric Cooperative, Inc. (ZAMSURECO-I), through its Pre-Bids and Awards Committee (PBAC), hereby invites all interested licensed security agencies to submit eligibility documents and bid for the provision of Security Services.

TECHNICAL REQUIREMENTS:

- Duration of Contract - Three (3) Years, starting April 1, 2012 to March 31, 2015 subject to periodic performance evaluation
- Number of Security Guards - 50 (1st half) security guards
44 (2nd half) security guards

The scope of technical requirements details are outlined in the Bid Documents to be provided to all interested bidders upon application and payment of Non-Refundable fee of One Thousand Six Hundred Eighty Pesos (Php1,680.00).

Bidding shall be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is open to all interested bidders, subject to the conditions for eligibility provided in the IRR of R.A. 9184.

Interested parties must submit a letter of Intent ("LOI") as well as all pre-qualification documents to the ZAMSURECO-I General Manager Attention: Prequalification, Bids and Awards Committee, which shall state the full name, address, telephone and fax numbers of the interested party, name of the principal contact, and signed by an authorized representative.




Late bids shall not be accepted
